March 5, 2013

The City of Hiawassee met at a regular Council meeting March 5, 2013, at City Hall, at 4:00pm. Present were Mayor Barbara Mathis, Wylene White, City Clerk, Rick Stancil, City Manager, Don Baker, City Engineer and Arvel Walls, City Police Sergeant.

Guest were Libby and Reggie Shook, Towns County Herald and Scarlett Fuller, HRWC.

Mayor Mathis called the meeting to order and welcomed all guests.

Stephen made a motion for the Adoption of the Final Agenda, seconded by Junior with all in favor.

Jane Kuck will be placed on a later agenda.

The Council discussed the need for a Flag Pole at the front of City Hall, Rick will get prices and send to the Council.

The Mayor would like to hold the Open House for the New City Hall on Tuesday, April 2nd, beginning at 12:00 noon and leading to the Council meeting at 4:00 pm. The Council discussed having a Dedication with Refreshments and tours of the facilities.

Stephen made a motion for the Resolution designating Place and Time of Hiawassee Council Meetings, Location of City Court and Place of Business, seconded by Junior with all in favor.

Stephen made a motion for the Resolution ratifying LOST Settlement, seconded by Junior with all in favor.

2013 USDA Bond Ordinance was put on hold until April Council Meeting at the request of the City Manager.

Junior made a motion for the Resolution calling for Local Legislative Delegation to introduce Local Legislation calling for a Referendum on the Sale of Liquor within the City Limits of Hiawassee, seconded by Joan with all in favor.

Scarlett Fuller briefly advised the Council of her recent activities in working with High School Classes and Students on Watershed issues.

Don Baker updated the Council on the 2012 Water Audit that has been filed with the State. Copies will be emailed by the City Manager to the Council, contact Don in the event there are questions. The Audit will be reviewed with the Water Department and Water Treatment Plant employees.
