The Hiawassee City Council met in regular session on Tuesday, April 2, 2012 at 4:00 p.m. at City Hall. Mayor Barbara Mathis called the council to order.

Mayor Mathis called the Meeting to Order at 4:00 p.m. and Adoption of Final Agenda.
